During the business portion of the Annual Meeting, we will give you an overview of last year and cover pending issues on the horizon, like the new Environmental Protection Agency (EPA) rule designed to regulate carbon dioxide emissions from existing power plants.

We care about the price of electricity because we're a not-for-profit electric co-op that looks out

for our members and their checkbooks. The EPA's proposed 44.4 per cent CO₂ emission reduction for Georgia by 2030 could force an increase in the cost of electricity and erode the reliability of our power supply.



Relying on diverse fuel sources for electric generation is the best way to keep electric bills affordable. Whether our electricity is generated using nuclear power, natural gas, coal, solar panels, landfill gas or hydro, we take our responsibility seriously to provide reliable and affordable electricity while doing our

best to protect the environment. Higher electricity prices created "artificially" due to mandated EPA actions and not as a result of true economic necessity would hurt businesses of all types, potentially leading to slower job growth or loss.

The EPA will be soliciting public comments until October 16. We encourage not only our members, but everyone in the region, to speak up. Please consider visiting www.Action.coop or www.TellEPA.com if you wish to tell the EPA officials in Washington, D.C. that we can't afford higher electric bills that will result from their 1,600+ page proposed rule and supporting documents.

We are bridge builders and path finders and are always open to new ideas and compromise, so long as it is fair and balanced.
